WHEREAS, on August 6, 2007 the Sangguniang Panlungsod of Muntinlupa approved Resolution No. 07-008, entitled, "a resolution authorizing the city mayor Hon. Aldrin L. San Pedro to secure or obtain a loan in any reputable banking institution in the amount of One Billion Pesos (Php1,000,000,000.00) for the construction of New City Hall Building of the City of Muntinlupa";

WHEREAS, it is not necessary at this point in time to construct the New City Hall Building at Civic Center, Filinvest Corporate City, Alabang because the renovated old city hall building is sufficient to cater and accommodate the needs of the constituents of the City of Muntinlupa and adjacent places who need the services of city government;

WHEREAS, the said amount needs to be realigned in order to finance the various infrastructure projects and programs of the City Government of Muntinlupa;

WHEREAS, the amount of One Billion Pesos (Php1,000,000,000.00) subject of this realignment is a part of the stand-by loan/credit of the City Government;

WHEREAS, the Budget Officer, emphasized that after the bidding process for the different projects they shall be referred back to the City Council for review and approval;

NOW, THEREFORE, BE IT ORDAINED, AS IT IS HEREBY ORDAINED. by the 5th Sangguniang Panlungsod in session assembled that the **One Billion Pesos** (Php1,000,000,000.00) allotted for the construction of a **New City Hall Building at Civic Center**, **Filinvest Corporate City**, **Alabang**, be re-aligned to finance various infrastructure projects and other programs of the City Government.
