**A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO GRANT FINANCIAL ASSISTANCE TO THE MEMBERS OF NAGKAKAISANG SAMAHAN NG MGA MALILIIT NA MANGINGISDA SA LUNGSOD NG MUNTINLUPA (NAGSAMA) FOR THE CONSTRUCTION OF BANGUS FISH PEN PROJECT AS SOURCE OF LIVELIHOOD IN THE AMOUNT OF TWO MILLION SIXTY SIX THOUSAND TWO HUNDRED NINETY PESOS (PHP2,066,290.00) TO BE TAKEN FROM THE 2008 EXECUTIVE BUDGET UNDER THE COMMUNITY DEVELOPMENT FUND (CDF).**

**WHEREAS**, Section 458 (a) of the Local Government Code of 1991, states that the Sangguniang Panglungsod, as the legislative body shall enact ordinances and approved resolutions xxx and appropriate funds for the general welfare of the city and its inhabitants pursuant to Section 16 of this code and in the proper exercise of the corporate powers of the city as provided for under Section 22 of this Code;

**WHEREAS**, Chapter 4, Section 36 of the Local Government Code of 1991, provides that, "a local government unit may through its Local Chief Executive and with the concurrence of the Sanggunian concerned, provide assistance, financial or otherwise, to such people's and non-governmental organizations for economic, socially-oriented, environmental, or cultural projects to be implemented within its territorial jurisdiction";

**WHEREAS**, the marginal fisherfolks of the City of Muntinlupa who belong to *Nagkakaisang Samahan ng mga Maliliit na Mangingisda sa Lungsod ng Muntinlupa (NAGSAMA)* have been experiencing hardship in life due to present economic situation;

**WHEREAS**, the said small fishermen organization has requested the City Government of Muntinlupa through the City Mayor Hon. Aldrin L. San Pedro to provide them source of livelihood;

**WHEREAS**, the request in order to alleviate the living condition of the said marginal fisherfolks city government has granted their request by providing five (5) hectares "***bangus fish pen project***" at Barangay Sucat, City of Muntinlupa;

**WHEREAS**, the City Government of Muntinlupa shall provide to the said marginal fisherfolks organization the amount of **TWO MILLION SIXTY SIX THOUSAND TWO HUNDRED NINETY PESOS (Php2,066,290.00)** for the purchase of materials and payment of labor in the construction of the said "***bangus fish pen project***" including the cost of bangus fingerlings that would be dispersed therein;

**WHEREAS**, the said "***bangus fish pen project***" shall be properly administered by the members of the said small fishermen organization to assure that income derived from the project reach each and every member of the organization;

**WHEREAS**, the organization is mandated to reserved 25% of the income derived from the "***bangus fish pen project***" as expenses of its maintenance to assure continuity of the project;

**WHEREAS**, as certify by the **Budget Office** there is an appropriated appropriation for livelihood assistance to be taken from the 2008 Executive Budget under the Community Development Fund (CDF) of the city;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, authorizing the **Hon. City Mayor Aldrin L. San Pedro**, to grant financial assistance to the members of **Nagkakaisang Samahan ng mga Maliliit na Mangingisda sa Lungsod ng Muntinlupa (NAGSAMA)** for the construction of "***Bangus Fish pen Project***" as source of livelihood in the amount of **Two Million Sixty Six Thousand Two Hundred Ninety Pesos (Php2,066,290.00)** to be taken from the **2008 Executive Budget** under the **Community Development Fund (CDF)**.
