RESOLUTION NO. 08-166

A RESOLUTION GIVING AUTHORITY TO HON. CITY MAYOR ALDRIN L. SAN PEDRO THAT MONIES COLLECTED BY ALL NON-GOVERNMENTAL ORGANIZATIONS (NGO's) AND THE LIKE TO UNDERGO MANDATORY AUDITING AND ACCOUNTING PROCEDURES AND TO FORMULATE GUIDELINES FOR ITS DISBURSEMENT.

WHEREAS, the law requires that receivable and collectible monies of the local government units arising from taxes, revenues, or **receipts of any kind** shall be remitted to the treasury which shall be credited to the particular account or accounts to which the monies in question properly belongs, either as general, special or trust fund;

WHEREAS, likewise, private or public monies which have officially come into the possession of the LGU are held in trust for the fulfillment of some obligation and could only be used for the specific purpose for which it was created or for which it came into the possession of the LGU;

WHEREAS, that monies collected by any non-governmental organizations, such as the **Senior Citizens, Boys Scout of the Philippines, Philippine National Red Cross and etc.**, in cinemas and other establishments within the City of Muntinlupa to defray the expenses of their civic programs and projects are considered public funds since the same were first remitted to the City Treasury, and therefore subject to auditing and accounting procedures;

WHEREAS, while **Article 62 of the Rules and Regulations Implementing the Local Government Code of 1991** provides that, "the Local Government Units shall promote the establishment and operation of people's organizations, NGOs, and the private sector, to make them active partners in the pursuit of local autonomy, the local government has likewise full authority to supervise and control the maintenance, operation and management of their affairs";

RESOLVED, THEREFORE, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to give authority to **Hon. City Mayor Aldrin L. San Pedro** that monies collected by all non-governmental organizations and the like to undergo mandatory auditing and accounting procedures and to formulate guidelines for its disbursement.


