**WHEREAS**, Article II, Section 5 of the Philippine Constitution, states that, ***"The maintenance of peace and order, the protection of life, liberty, and property, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy"***;

**WHEREAS**, Republic Act 7160 otherwise known as the Local Government Code of 1991, further provides that, ***"Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support among other things, xxxxxxxx, promote health and safety, xxxxxxxxx, improve public morals, xxxxxxxx, and social justice, xxxxxxxxxx, maintain peace and order, and preserve the comfort and convenience of their inhabitants"***;

**WHEREAS**, only when peace and order, security, safety and a life of dignity are established and maintained, will social stability become attainable and the people truly enjoy the blessings of independence and democracy;

**WHEREAS**, the lack of necessary lightings and precautionary devices on the PNCC's ongoing road construction and rehabilitation truly endanger the life and property of the motorist passing to and fro along the stretch of **South Expressway** and **Alabang Viaduct**, especially during night time;

WHEREAS, in order to avoid such damage to property, injury or even loss of life, the PNCC management must observe the degree of care, precaution and vigilance for the protection of the motorist, as required by the circumstances of the place;

NOW THEREFORE, BE IT RESOLVE, AS IT IS HEREBY RESOLED, by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, to urge the **Philippine National Construction Corporation (PNCC)** to provide the **necessary lightings** and **precautionary devices** on its ongoing road construction and rehabilitation within the jurisdiction of Muntinlupa City.

RESOLVED FURTHER, that a copy of this Resolution be given personally to the **Office of the Philippine National Construction Corporation (PNCC)**.






