**WHEREAS**, Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, **“xxxxxxxxxxxx. Within their respective territorial jurisdictions, local government units shall ensure and support among other things, xxxxxxxxxxx, improve public morals, enhance economic prosperity and social justice, xxxx, maintain peace and order, and preserve the comfort and convenience of their inhabitants”**;

**WHEREAS**, Section 12 of the same Code further states that, **“Provinces, cities, and municipalities shall endeavor to establish a government center where offices, agencies, or branches of the National Government, local government units, or government-owned or –controlled corporations may, as far as practicable, be located”**;

**WHEREAS**, at present, the City of Muntinlupa has **seven (7) Regional Trial Courts, one (1) Municipal Trial Court and twenty (20) Prosecutors Offices** and the City Government is spending almost **Two Hundred Fifty Thousand Pesos (P250,000.00)** for its monthly rentals;

**WHEREAS**, compared to other public functions and duties, the dispensing of justice, being extremely important, is both delicate and singular. To sit in judgment over one's fellowmen, to pass upon their controversies involving their rights and fortunes, and in criminal cases, determine their innocence or guilt, which decision affects and involves their freedom, their honor, even their lives, is no ordinary chore of business. It is a serious task, weighty and fraught with grave responsibility and far-reaching effects, a task earnest and solemn, almost partaking of the divine, and therefore, prosecutors and justices deserves a descent Hall of Justice with an atmosphere conducive to a true administration of justice;

**WHEREAS**, the City Government of Muntinlupa needs a parcel of lot consisting of five thousand (5,000) square meters for the construction of **Muntinlupa Justice Hall**;

**WHEREAS**, the only area that would provide such facility is the New Bilibid Prison Reservation area;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 5<sup>th</sup> Sangguniang Panlungsod, to request Her Excellency President Gloria Macapagal-Arroyo to allocate a parcel of lot consisting of Five Thousand (5,000) square meters at the New Bilibid Prison (NBP) Reservation area for the construction of Muntinlupa Justice Hall.
