WHEREAS, specifically the MUNICIPALITY OF RIZAL, PROVINCE OF NUEVA ECIJA intends to enter into a *Memorandum of Agreement (MOA)* with the City of Muntinlupa, related to the transfer of technology on the Real Property Tax (RPT) Administration System, the Business One Stop Shop (BOSS) System, Training of Municipal Government's Personnel and sharing of LGU best practices;

WHEREAS, the sisterhood relationship shall establish an agreement on cooperation to promote and expand an effective and mutually beneficial cooperation in the development of both local governments, within the limits of their financial, material and personnel capabilities;

WHEREAS, the MUNICIPALITY OF RIZAL, PROVINCE OF NUEVA ECIJA, will transfer their agricultural products for the Markets of Muntinlupa;

WHEREAS, both Local Government Units agree to establish a Joint Working Group equally represented by each party, the joint Technical Working Group shall prepare and recommend short term and medium term fields of activities and shall monitor its implementation. The Joint Working Group shall meet every other month in this concern;
