A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF FIGUREHEAD CORPORATION TO THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE (PCSO) TO CONDUCT AND MANAGE THE SMALL TOWN LOTTERY (STL) WITHIN THE JURISDICTION OF THE CITY OF MUNTINLUPA SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS.

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) is the principal agency of the government that is mandated by law, specifically, **Republic Act No. 1169**, as amended by **Batas Pambansa Bilang 42** and **Presidential Decree No. 1157**, and the **PCSO Board Resolution No. 118**, series of 1987 to conduct a **Small Town Lottery Project** to raise and to provide funds for the government health projects, for medical assistance and services, and for charities of national character through the conduct of lotteries;

WHEREAS, the STL has been proposed to serve as the only legitimate and economically viable alternative to jueteng (an illegal numbers game), PCSO operates and shall operate the STL nationwide in partnership with reputable and legitimate corporations as its authorized agents. These agent-corporations shall, in turn, employ bet collectors and supervisors to effectively reach out to the populace;

WHEREAS, the following objectives for the said Small Town Lottery project as a government-run numbers games, is being implemented with the aims of:

- a. Sourcing out additional charity funds for the PCSO;
- b. Generating funds at the provincial and municipal levels for local charitable undertakings, economic development, and social amelioration activities;

- c. Combating jueteng and other illegal numbers games;
- d. Finding alternative sources of income for those who are economically displaced by the eradication of jueteng and other illegal numbers games through the employment of these collectors, cabos, and employees with the implementation of the STL; and
- e. Providing opportunities for employment for the masses with less educational qualifications, other than those displaced by the eradication of jueteng, as regular sales representatives of the STL.

WHEREAS, the allocation of proceeds, pursuant to pertinent policies, regulations and issuances by the PCSO Board of Directors, the following reflects the appropriate and due allocation of STL proceeds, to be duly apportioned, remitted and sufficiently reported:
