WHEREAS, the Handog Industrial Gases Distributor (HIGD) supply gases to the Ospital ng Muntinlupa;

WHEREAS, the comparative prices of gases were as follows: the Consolidated Industrial Gases Inc., (CIGI) for Three Hundred Ninety Pesos (Php390.00), the Caloocan Gas for Three Hundred Seventy Pesos (Php370.00), while the Handog Industrial Gases Distributor for only Three Hundred Twenty Pesos (Php320.00);

WHEREAS, the HANDOG has been in the business of distribution of industrial gases for sometime in the Philippines, both in the government and the private sector. It is also capable of providing all the necessary industrial gases, including the necessary equipments related therewith to OSMUN;

WHEREAS, this supply agreement shall be effective for a period of one year and not exclusive to HANDOG Distributor only;

WHEREAS, the OSMUN generates income from the use of medical gases;

WHEREAS, the said contract is negotiated and shall comply with the bidding process to be conducted by the Bids and Awards Committee six (6) menths before expiration of the contract;

WHEREAS, this contract shall be null and void without the bidding

process provided in the Procurement Act;
