The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, MR. RODOLFO I. OLiQUINO born and raised in Muntinlupa, a graduate at the *Putatan Elementary School* and *Muntinlupa National High School*, and finished *Bachelor of Science in Commerce Major in Accounting* at the *Manuel L. Quezon University* in 1984;
