WHEREAS, on September 27, 2008, Her Excellency President Gloria Macapagal- Arroyo appointed **Police Director General Jesus A. Verzosa** as the new Philippine National Police Chief, replacing **Police Director General Avelino Razon, Jr.** who retired from the service;

WHEREAS, **POLICE DIRECTOR GENERAL JESUS A. VERZOSA** was born on *December 25, 1954* at *Dasol, Pangasinan* by *Col. Pedro C. Verzosa*, a retired Philippine Army Officer and *Mrs. Luz Ame Verzosa* of *Blk. 9 Soldiers' Hills Village, Putatan, Muntinlupa City*, and married to *Ms. Cynthia Verzosa* to whom he has two (2) children, namely: *Joyce Arnie (18)* and *Eric (17)*;

WHEREAS, **POLICE DIRECTOR GENERAL JESUS A. VERZOSA**, a graduate of the Philippine Military Academy (PMA), Class 1976, took his primary education at *Itaas Elementary School* in 1967, as a valedictorian; his secondary education at *Muntinlupa National High School (MNHS)* in 1971, as a valedictorian; finished his *Bachelor of Laws* at *Jose Rizal College* in 1996, and *Master in Business Administration* at *Northwestern College* in 2000;

WHEREAS, upon graduation from PMA in 1976, **POLICE DIRECTOR GENERAL JESUS A. VERZOSA** saw action in the field as *Platoon Leader* and later as *Company Commander* under the *54th PC Battalion* in *Tuburan, Basilan* and in *Parang Maguindanao* during the height of the *Mindanao campaign*;

WHEREAS, upon his return to Luzon, he was assigned to various positions in the PC Metrocom until he returned to the field in 1986 as Chief of the Intelligence and Investigation Branch of the Rizal PC/INP Command;

WHEREAS, his other notable stints in the field were as District Director of the Criminal Investigation Service in Western Visayas; Commanding Officer of the 358th PC Company in Capooan, Leyte; Regional Officer of the 4th CIC Regional Office in Southern Tagalog; City Director of the Baguio City Police Office; Regional Officer of the NCR-CIG; Director of the Aviation Security Group; Director of the Intelligence Group; PNP Regional Director for Cordillera; PNP Regional Director for Calabarzon; and Director of the Criminal Investigation and Detection Group;

WHEREAS, POLICE DIRECTOR GENERAL JESUS A. VERZOSA has served a well-rounded career as an officer before eventually being elevated to top level positions in the Directorial Staff and Command Group, and as Executive Director of the Program Management Office;

WHEREAS, POLICE DIRECTOR GENERAL JESUS A. VERZOSA is the recipient of numerous awards for outstanding accomplishments including the prestigious Lingkod ng Bayan Award from the Civil Service Commission, two (2) Cavalier Awards from the PMA Alumni Association; and service medals for efficiency, merit and outstanding achievement;

WHEREAS, as Deputy Chief for Administration under former PNP Chief Avelino Razon Jr., his impressive track record of performance makes him the best choice for the top PNP post and as the 15th Chief of the PNP;

WHEREAS, PDG VERZOSA's feat brings prestige, pride and honor to the people of Muntinlupa City, and therefore, deserves commendation and due recognition from the City Government of Muntinlupa, under the administration of **Hon. City Mayor Aldrin L. San Pedro**;






