**WHEREAS**, Section 22 (c) of the Local Government Code of 1991, provides that, *"unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned"*;

**WHEREAS**, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the same code, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

**WHEREAS**, the **HITACHI ELEVATORS/ESCALATORS (HI-ELES) INDUSTRIAL CORPORATION** rendered services for the maintenance and inspection of the elevators at the Ospital ng Muntinlupa;

**WHEREAS**, the **HITACHI ELEVATORS/ESCALATORS (HI-ELES) INDUSTRIAL CORPORATION** set-up the elevators equipment at the Ospital ng Muntinlupa (OSMUN);

WHEREAS, the equipments installed at Ospital ng Muntinlupa are herein described as follows:

- BED ELEVATOR – 1000 Kgs. – 2S60 – 4S/4F x 2**
- BED ELEVATOR – 750 Kgs. – CO60 – 4S/F x 1**

WHEREAS, there is a need for **HITACHI ELEVATORS/ESCALATORS (HI-ELES) INDUSTRIAL CORPORATION** to maintain and inspect the elevators because it is necessary for the OSMUN;

WHEREAS, the **HITACHI ELEVATORS/ESCALATORS (HI-ELES) INDUSTRIAL CORPORATION** will provide the services of qualified servicemen for the purpose of examining the elevator, cleaning and adjustment of all motor control safety devices, greasing and oiling of all bearing of equipment based on **HITACHI ELEVATORS/ESCALATORS (HI-ELES) INDUSTRIAL CORPORATION** standard service schedule;

WHEREAS, the HI-ELES will undertake the service and inspection services for and in consideration of Nine Thousand Pesos (Php9,000.00) inclusive of 12% Vat which the City Government agrees to pay a monthly service fee payable within ninety (90) days after the agreed service of twice (2) a month has been rendered.

WHEREAS, the Maintenance Agreement executed by the Hon. City Mayor Aldrin L. San Pedro in behalf of the Ospital ng Muntinlupa with **HITACHI ELEVATORS/ESCALATORS (HI-ELES) INDUSTRIAL CORPORATION** represented by Eng. Eduardo Alob is hereto attached and shall be made an integral part of this resolution;

**NOW THEREFORE, BE IT RESOLVEED, AS IT IS HEREBY RESOLVE,** by the 5<sup>th</sup> Sangguniang Panlungsod of Muntinlupa to authorized the Hon. City Mayor Aldrin L. San Pedro in behalf of the Ospital ng Muntinlupa to execute and sign the Maintenance Agreement with Hitachi Elevators/Escalators (HI-ELES) Industrial Corporation represented by Eng. Eduardo Alob for the maitenance and inspection services of the elevators at the Ospital ng Muntinlupa (OSMUN).


