WHEREAS, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *"unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations"*. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed";

WHEREAS, ATTY. ISIDORO L. SORIANO, JR. born and raised in Muntinlupa, a graduate at the Buli Elementary School and high school at the Makati Polytechnic Community College, and finished Bachelor of Arts in Political Science and further Bachelor of Law in 1988 at Far Eastern University respectively;

WHEREAS, in 1996, ATTY. ISIDORO L. SORIANO, JR. passed the BAR Examination and also passed the Civil Service Professional Examination;

WHEREAS, ATTY. ISIDORO L. SORIANO, JR. started his public service as an appointed Barangay Kagawad of Barangay Buli from 1986 to 1989;


