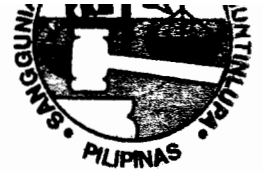

RESOLUTION NO. 08-211

A RESOLUTION GRANTING THE REQUEST OF EXPEDITION CONSTRUCTION CORPORATION FOR A 30% INCREASE IN THE CONTRACT PRICE OF ONE HUNDRED TWENTY NINE MILLION, SIX HUNDRED EIGHTY FIVE THOUSAND PESOS (PHP129,685,000.00) FOR GARBAGE HAULING AND DISPOSAL SERVICES OF THE CITY GOVERNMENT OF MUNTINLUPA TO BE PAID NEXT YEAR AND CONSIDERED AS PRIORITY OBLIGATION OF THE CITY AND SHALL BE INCORPORATED IN THE 2009 EXECUTIVE BUDGET.

WHEREAS, the contract of **EXPEDITION CONSTRUCTION CORPORATION** for the garbage collection, hauling and disposal services in the City of Muntinlupa was signed and executed last January 31, 2008 up to December 31, 2008;

WHEREAS, the 5th Sangguniang Panlungsod passed Resolution No. 08-064 entitled, "*Resolution authorizing the Hon. City Mayor Aldrin L. San Pedro to enter into a new contract in behalf of the City Government of Muntinlupa with EXPEDITION CONSTRUCTION CORPORATION for garbage collection and disposal services for the year 2008 amounting to Ten Million Eight Hundred Seven Thousand Eighty Three Pesos and 33/100 (Php10,807,083.33) with the total amount of One Hundred Twenty Nine Million, Six Hundred Eighty Five Thousand Pesos (Php129,685,000.00) from January 31, 2008 to December 31, 2008*";

WHEREAS, in the exigency of public service and so as not to disrupt the continued collection and disposal of garbage in the City of Muntinlupa there is an imperative need to grant the request of Expedition Construction Corporation to avoid a garbage crisis which may seriously affect the good health of the people;

WHEREAS, the City Council grants the request of Expedition Construction Corporation for a 30% increase of the contract price, which is *One Hundred Twenty Nine Million, Six Hundred Eighty Five Thousand Pesos (Php129,685,000.00)*, due to the rapid increase of cost of fuel and maintenance expenses. Such increase is to be paid next year and considered as priority obligation of the city. Further such increase shall be incorporated in the 2009 Executive Budget;

WHEREAS, after reviewing the request of the contractor the BAC recommended a **thirty percent (30%)** increase in the contract price;

WHEREAS, the approved thirty percent (30%) increase will commence on October 1, 2008;

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, to grant the request of Expedition Construction Corporation for a 30% increase in the contract price of **One Hundred Twenty Nine Million, Six Hundred Eighty Five Thousand Pesos (Php129,685,000.00)** for garbage hauling and disposal services of the City Government of Muntinlupa to be paid next year and considered as priority obligation of the City and shall be incorporated in the 2009 Executive Budget of the City.
