A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT BY AND BETWEEN THE COUNCIL ON THE WELFARE OF CHILDREN (CWC/NECCDCC AND THE REGIONAL COMMITTEE/SUB-COMMITTEE FOR THE WELFARE OF CHILDREN (RC/SCWC) FOR THE IMPLEMENTATION OF REPUBLIC ACT NO. 8980.

WHEREAS. Republic Act No., 8980, an Act promulgating a Comprehensive Policy and National System for Early Childhood Care and Development, otherwise known as the ECCD Act was signed into law on December 5, 2000;

WHEREAS, the law aims to institutionalize nationwide within a period of five (5) years, a National ECCD System that is comprehensive, integrative and sustainable, that involves multi-sectoral and inter-agency collaboration at all levels of government;

WHEREAS, Section 8 of Republic Act 8980 (ECCD Law) stipulate the creation of National Coordinating Council and Coordinating Committee for ECCD/ to ensure the sustained inter-agency and multi-sectoral collaboration from the national, provincial, city/municipal and barangay committees with the council for the Welfare of Children (CWC) serving as the national ECCD Coordinating Council:

WHEREAS, Section 40 of the Implementing Rules and Regulation of said law state that, "the Regional Committee/Sub-Committee for the welfare of children (RC/SCWC) of the Regional Development Council (RDC) shall function as an extension of the NECCDCC to coordinate the planning, implementation, monitoring and evaluation of all policies and programs for children, appraise and recommend approval to the NECCDCC of the work and financial plans submitted by the Provincial/HUC ECCD Coordinating Committee; and advocate the promotion of ECCD and provide technical assistant to all stake holders in the region and perform such other functions as may be directed by the NECCDCC;

WHEREAS, the law provides for an appropriation sourced from the gross income of the Philippine Amusement and Gaming Corporation (PAGCOR) to be directly remitted to a special account of CWC to finance and upgrading of the LGU support to existing health-related public ECCD programs and to Day Care Program, Parent Effectiveness Service and other Parent-Child Development Programs, among others;

WHEREAS, CWC/NECCDCC, RC/SCWC and the Local Government Unit (Province/HUC/Municipality) agree that there is a need for clear delineation of roles and responsibilities in ensuring the accomplishment of the ECCD program goals and objectives;

WHEREAS, this MOA defines the roles and responsibilities of CWC/NECCDCC, RC/SCWC and the City Government in implementing the projects and activities under the ECCD Program as provided for under this agreement;

WHEREAS, the CWC/NECCDCC as the lead agency for execution of the project shall, in addition to its functions provided in the ECCD Act, have the responsibility to:

- 1) Formulate and adopt a 5-year ECCD plan which shall be the basis of the PAGCOR in remitting funds to CWC and the 3-year ECCD Investment Plan at the local level;
- Maintain a special account for the funds received from PAGCOR, and administer the same in accordance with existing government procedures and financial guidelines for the implementation of the ECCD Act;
- 3) Evaluate and approved the 3-year ECCD Investment Plan and Annual Work and Financial Plan submitted by the City Government;
- 4) Allocate the funds sourced from PAGCOR among the provinces/highly urbanized cities based on approved criteria;
- 5) Release the funds in a timely manner, to the City Government based on the approved annual WFP;
- 6) Monitor and assess the overall ECCD Program implementation, and formulate additional policies and guidelines as may be necessary;



8) Submit a quarterly report of accomplishment to PAGCOR to account for funds received and utilized:

WHEREAS, the City Government shall, in addition to the functions of the Local Government Units enumerated in the ECCD Act, have the responsibility to:

> 1) Integrated in the City Development Plan (CDP), the projects and activities to implement the ECCD Program including those to be implemented by the city;

> 2) Prepare a 3-year Investment Plan (IP) for the ECCD program to be approved by the City Council and prepare corresponding annual and Financial Plan (WFP) be to CWC/NECCDCC for approval thru the RC/SCWC;

> 3) The Local Government Unit (LGU), through the Mayor, shall create or strengthen LCPC which shall serve as the City ECCD Coordinating Committee through issuance of a Resolution or Executive Order including appointment of designation of the ECCD Officer:

> 4) Maintain a Special Trust Account solely for the funds received from CWC/NECCDCC intended for ECCD programs;

> 5) Receive the grant from the CWC/NECCDCC for the implementation of the ECCD projects/programs/activities of the whole city and be accountable to CWC/NECDCC for all the funds and other resources received:

> 6) Ensure that the funds are expended and utilized according to the approved annual WFP and administer the same in accordance with existing government procedures and the financial guidelines for the implementation of the ECCD Act;

> 7) Commit itself and likewise ensure the commitments of barangays to support and participate in all programs that will be implemented in their areas;

> 8) Provide the office space, furniture and fixtures, supplies, equipment and other requirements such as IEC materials and other forms of technical support to Local Government Unit in the implementation of the Project;

> 9) Establish and maintain an ECCD Management Information System (MIS);

> 10) Submit a quarterly physical and other required consolidated reports to CWC/NECCDCC in a timely manner based on the existing quidelines:

> 11) Submit to CWC/NECCDCC a monthly and annual financial report properly audited by COA auditor pursuant to COA Circular No. 94-013 dated December 13, 1994 and in accordance with the financial guidelines;

*12)Maintain separate journals and ledgers for the ECCD program transactions for control purpose;

WHEREAS, the funds transferred by the CWC/NECCDCC as grant to the City Government for the implementation of the ECCD program, including the LGU counterpart, shall be maintained as a separate ECCD-Trust Account of the City Government. Disbursement of funds shall be guided by approved annual work and Financial Plan:

WHEREAS, the total cost of the projects/programs/activities to implement the ECCD program shall be shared between the CWC/NECCDCC and the City of Muntinlupa as follows:

CWC/NECCDCC - 60% CITY OF MUNTINLUPA - 40%

NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Muntinlupa, authorizing the *Hon. City Mayor Aldrin L. San Pedro* to enter into a **Memorandum of Agreement (MOA)** in behalf of the City Government by and between the Council on the Welfare of Children (CWC/NECCDCC and the Regional Committee/Sub-Committee for the Welfare of Children (RC/SCWC) for the implementation of Republic Act No. 8980.
