A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH JBA ESPEJO CONSTRUCTION, FOR THE PROJECT CONSTRUCTION OF OVERHEAD FENCING LOCATED AT PLANASVILLE, TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF FIVE HUNDRED EIGHTEEN THOUSAND PESOS (PHP518,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE APPROVED SUPPLEMENTAL BUDGET NO. 1.

WHEREAS, however, to further enhance transparency and accountability Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, on March 31, 2008, the 5th Sangguniang Panlungsod approved ordinance No. 08-036, entitled, "an ordinance appropriating the amount of One Billion Pesos (Php1,000,000,000.00) as Supplemental Budget No. 1 for Calendar Year 2008 of the City of Muntinlupa, which shall be funded from the total amount duly certified by the City Treasurer as funds available for appropriation amounting to One Billion Pesos (Php1,000,000,000.00)";

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the **Construction of Overhead Fencing at Planasville, Tunasan, Muntinlupa City** in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, single contractor submitted letters of intent and applications for eligibility, and same was found eligible on July 23, 2008;

WHEREAS, single bid was submitted on August 6, 2008 and bid passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bid conducted on August 11, 2008 resulted in the following:

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with the single calculated bid, **JBA Espejo Construction**, its bid has been found to be responsive;

WHEREAS, the amount appropriated for the said project shall be taken from the approved Supplemental Budget No. 1 as stated in Ordinance No. 08-036;

WHEREAS, the approved budget of the contract for the project is **Five Hundred Twenty Thousand Seven Hundred Eighty Pesos and 73/100 (Php520,780.73)**;

WHEREAS, the project was awarded to **JBA Espejo Construction**, who being the single bidder for the project, construction of overhead fencing at Planasville, Tunasan, Muntinlupa City;




