A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH EXPEDITION CONSTRUCTION CORPORATION, FOR THE PROJECT IMPROVEMENT OF SIDEWALK, INSTALLATION OF STREETLIGHTS AND CONSTRUCTION OF PLANT BOXES AND RAILINGS LOCATED AT ALABANG VIADUCT, ALABANG, MUNTINLUPA CITY IN THE AMOUNT OF NINETEEN MILLION NINE HUNDRED FIFTY THOUSAND FOURTY EIGHT PESOS AND 80/100(PHP19,950,048.80) WHICH AMOUNT SHALL BE TAKEN FROM THE APPROVED SUPPLEMENTAL BUDGET NO. 1.

WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "**xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others**";

WHEREAS, pursuant to Section 76 of RA. 9184 states that, "**any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly**";

WHEREAS, however, to further enhance transparency and accountability Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, on March 31, 2008, the 5th Sangguniang Panlungsod approved ordinance No. 08-036, entitled, "**an ordinance appropriating the amount of One Billion Pesos (Php1,000,000,000.00) as Supplemental Budget No. 1 for Calendar Year 2008 of the City of Muntinlupa, which shall be funded from the total amount duly certified by the City Treasurer as funds available for appropriation amounting to One Billion Pesos (Php1,000,000,000.00);**

WHEREAS, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project improvement of sidewalk, installation of Streetlights and construction of plant boxes and railings located at Alabang Viaduct, Alabang, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, three (3) contractors submitted letters of intent and applications for eligibility, and the three (3) were found eligible on July 23, 2008;

WHEREAS, three (3) were submitted on August 6, 2008 and bid passed the preliminary examination of bids;

WHEREAS, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with lowest calculated bid, Expedition Construction Corporation, its bid has been found to be responsive;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro in behalf of the City Government of Muntinlupa with Expedition Construction Corporation, for the project improvement of sidewalk, installation of streetlights and construction of plant boxes and railings located at Alabang Viaduct, Alabang, Muntinlupa City in the amount of Nineteen Million Nine Hundred Fifty Thousand Forty Eight Pesos and 80/100 (Php19,950,048.80) which amount shall be taken from the approved Supplemental Budget No. 1.




