**A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH SOCOR CONSTRUCTION CORPORATION FOR THE PROJECT ROAD CONCRETING LOCATED AT BULI, MUNTINLUPA CITY IN THE AMOUNT OF SIX MILLION EIGHT HUNDRED EIGHTY THOUSAND SIX HUNDRED THIRTY SIX PESOS AND 86/100 (PHP6,880,636.86) WHICH AMOUNT SHALL BE TAKEN FROM THE APPROVED SUPPLEMENTAL BUDGET NO. 1.**

**WHEREAS, Republic Act No. 9184, otherwise known as the Government Procurement Reform Act, states that, "xxx authorizes the Bids and Awards Committee (BAC) to conduct competitive bidding in the procurement of infrastructure projects among others";**

**WHEREAS, pursuant to Section 76 of RA. 9184 states that, "any other Law, Presidential Decree or issuance of Executive Order, letter of Instruction, Administrative Order, Proclamation, Charter, Rules or Regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly";**

**WHEREAS, however, to further enhance transparency and accountability Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;**

**WHEREAS, on March 31, 2008, the 5<sup>th</sup> Sangguniang Panlungsod approved ordinance No. 08-036, entitled, "an ordinance appropriating the amount of One Billion Pesos (Php1,000,000,000.00) as Supplemental Budget No. 1 for Calendar Year 2008 of the City of Muntinlupa, which shall be funded from the total amount duly certified by the City Treasurer as funds available for appropriation amounting to One Billion Pesos (Php1,000,000,000.00);**

**WHEREAS**, the City Government of Muntinlupa advertised the Invitation to Apply for Eligibility and to Bid of the project road concreting, located at Buli, Muntinlupa City in a newspaper of nationwide general circulation, posted at the Government Electronic Procurement System (GEPS) and City's Website and posted the same in the conspicuous place at the premises of the City Government of Muntinlupa continuously for seven (7) days;

**WHEREAS**, in response to the said advertisements, single contractor submitted letters of intent and applications for eligibility, and the same was found eligible on July 23, 2008;

**WHEREAS**, single was submitted on August 6, 2008 and bid passed the preliminary examination of bids;

**WHEREAS**, the detailed evaluation of bids conducted on August 11, 2008 resulted in the following:

**WHEREAS**, upon post-qualification or careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by the bidder with single calculated bid, SOCOR Construction Corporation, its bid has been found to be responsive;

**WHEREAS**, the amount appropriated for the said project shall be taken from the approved Supplemental Budget No. 1 as stated in Ordinance No. 08-036;

**WHEREAS**, the approved budget for the contract for the project is Six Million Eight Hundred Ninety Five Four Pesos and 88/100 (Php6,895,004.88);

**WHEREAS**, the project was awarded to SOCOR Construction Corporation who being the lowest bidder for the project, road concreting located at Buli, Muntinlupa City;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 5<sup>th</sup> Sangguniang Panlungsod to ratify the Construction Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro** in behalf of the City Government of Muntinlupa with **SOCOR Construction Corporation** for the project road concreting located at Buli, Muntinlupa City in the amount of **Six Million Eight Hundred Eighty Thousand Six Hundred Thirty Six Pesos and 86/100 (Php6,880,636.86)** which amount shall be taken from the approved Supplemental Budget No. 1.




