BIAZON, REPRESENTING THE LONE DISTRICT OF MUNTINLUPA, THRU THE PRIORITY DEVELOPMENT ASSISTANCE FUND (PDAF), TO DEFRAY THE COST OF THE LOCAL GOVERNMENT UNIT COUNTERPART PREMIUM CONTRIBUTION FOR THE ENROLLMENT OF QUALIFIED INDIGENT FAMILIES.

WHEREAS, Section 11, Article XIII of the 1987 Constitution, states that, *“mandates the state to adopt an integral and comprehensive approach to health development which shall endeavor to make essential goods, health and other services available to all people at affordable cost”*;

WHEREAS, to implement the aforementioned Constitutional provision, the Philippine Congress enacted Republic Act 7875, entitled, *“An act instituting a National Health Insurance Program (NHIP) Establishing the Health Insurance Corporation (PhilHealth)”* for the purpose;

WHEREAS, pursuant to RA 7875, as amended, and its Revised Rules and Regulations, provides that, *“the premium contributions for indigent members under the Sponsored Program of NHIP shall be subsidized partially by the LGU, where the members resides, and PhilHealth”*;

WHEREAS, in order to set into motion an efficient health care financing and delivery program anchored on local government autonomy, the contracting parties hereby acknowledge the need adopt mechanisms for the implementation of NHIP’s Regular In-Patient and Out-Patient Package (Phase I) for indigents;

WHEREAS, under the Priority Development Assistance Fund (PDAF), upon the prerogative of any member of the Congress, said fund may be utilized to assist Local Government Units (LGU’s) for their counterpart contribution to the Sponsored Program;

Biazon**, representing the Lone District of Muntinlupa, thru the **Priority Development Assistance Fund (PDAF)**, to defray the cost of the **Local Government of Muntinlupa** the counterpart premium contribution for the enrollment of qualified indigent families.

RESOLVED FURTHER THAT, the 5th **Sangguniang Panlungsod of Muntinlupa** is hereby request and seek assistance from the **Hon. Rozzano Rufino B. Biazon** representing the Lone District of Muntinlupa for the release of funds through the **Priority Development Assistance Fund (PDAF)** in the payment of the **Local Government of Muntinlupa** premium counterpart contribution.
