WHEREAS, Section 167 of Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, "**xxx all local taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter, as the case may be.**";

WHEREAS, Rule XVII, Article 101 (a.1) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "**the Sangguniang Barangay, as the legislative body of the barangay, shall enact tax and revenue ordinances, subject to the limitations imposed in the Code.**";

WHEREAS, as the payment of Business Permits, the first twenty (20) days of January the **local taxpayers** expressed **massive opposition/complaints** to the issuance of **Barangay Business Plates** which is an additional burden to them;

WHEREAS, to alleviate the difficulties of the taxpayers experiencing today due to worldwide financial crisis there is a need to suspend temporarily the said issuance of the **Barangay Business Plates** pending a meeting of all the Barangay Chair and all Department Heads concerned to address the said problem;

WHEREAS, any illegal exaction already made shall be credited to the taxpayer for the next tax season in 2010;
