WHEREAS, Section 16 of Republic Act 7160 otherwise known as the Local Government Code of 1991, provides that, "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. XXX local government units shall ensure and xxx promote health and safety, xxx";

WHEREAS, Section 17 (iii) (iv) of the same code, states that,

(iii) "subject to the provisions of Title Five, Book 1 of this Code, health services which include the implementations of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services; access to secondary and tertiary health services; purchase of medicines, medical supplies, and equipment needed to carry out the services herein enumerated":

> (iv) subject to the provisions of Title Five, Book 1 of this Code, health services which include hospitals and other tertiary health services;

WHEREAS, Section 18 of the same code, states that, "local government units shall have the power and authority to establish an organization that shall be responsible for the efficient and effective implementation of their development plans, program objectives and priorities";

WHEREAS, Section 448 of the same code, states that, "the city, consisting of more urbanized and developed barangays, serves as a general purpose government for the coordination and delivery of basic, regular, and direct services and effective governance of the inhabitants within its territorial jurisdiction";

WHEREAS, the Cervical Cancer Prevention (CECAP) Network is a national initiative based in Cancer Institute of the University of the Philippines-Philippine General Hospital which aims to reduce and eventually prevent the incidence of cervical cancer among Filipino women by increasing their awareness about the preventability of this disease and providing access to screening and treatment;

WHEREAS, Cervical Cancer Prevention (CECAP) Network is committed to empower Filipino women against cervical cancer:

- To promote healthy lifestyle though education and information campaigns;
- 2) To conduct trainings and providing quality service delivery through the single visit approach which include counseling, screening through Visual Inspection of the Cervix with Acetic Acid (VIA) linked to treatment (cryotherapy) or referral if necessary; and
- 3) To undertaking research on cervical cancer prevention including other effective and practical screening methods and cervical cancer vaccination;

WHEREAS, in line with the national thrust of the Department of Health to create awareness for cancer prevention and control, CECAP has been coordinating and partnering with local government unit in order to deliver anticervical cancer services in the grassroots level;

WHEREAS, Muntinlupa City has been designated as one of the three initial pilots sites in the Philippines by CECAP, in coordination with JHPIEGO, an affiliate of Johns Hopkins University, where CECAP will supervise the ongoing anti-cervical cancer program established in Muntinlupa City through monitoring and evaluator visits conducted by the CECAP Management Team;
