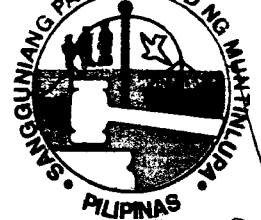

**A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO GRANT FINANCIAL ASSISTANCE TO 2,000 FAMILIES AT FIVE THOUSAND PESOS (PHP5,000.00) PER FAMILY OR FOR A TOTAL AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00) TO BE TAKEN FROM 20% COMMUNITY DEVELOPMENT FUND – ASSISTANCE TO INFORMAL DWELLERS.**

**WHEREAS**, the effort of the National Government thru National Housing Authority (NHA) to build infrastructure projects to facilitate the mobility of people from all around the country, the Northrail-Southernrail rehabilitation and modernization project is currently being undertaken to the detriment of thousands of informal settlers-families living along the PNR road-right-of-way;

**WHEREAS**, in the City of Muntinlupa, the clearing operations would leave approximately 10,555 families homeless;

**WHEREAS**, the 50 hectare relocation site, about 7,035 will be provided with housing but the remaining **3,520 families/settlers**, more or less will be left behind as they are disqualified to relocate to Southvill 3;

**WHEREAS**, the city government grants financial assistance in the amount of Five Thousand Pesos (Php5,000.00) each to disqualified families by way of support to the project of National Government thru National Housing Authority (NHA);

**WHEREAS**, there is an available budget for the purpose as certified and signed by the City Budget Officer;

**WHEREAS**, the Office of the City Mayor thru Urban Poor Affairs Office (UPAO) is authorized to prepare **the list of the** beneficiaries for the proper distribution of financial assistance;




