WHEREAS, the said Appropriation Ordinance was reviewed by the City Budget Office and was found to be **proper and in order**, having complied with the requirements setforth under the Local Government Code of 1991;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod to approve Barangay Appropriation Ordinance No. 01, Series of 2009, containing a budget of **TWENTY NINE MILLION SIX HUNDRED FIFTY ONE THOUSAND TWO HUNERED FIFTEEN PESOS (PHP29,651,215.00)**, of Barangay Cupang, Muntinlupa City for Calendar Year 2009.




