A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO GRANT ADDITIONAL FINANCIAL ASSISTANCE TO DISQUALIFIED FAMILIES WITH A TOTAL AMOUNT OF ONE MILLION SIX HUNDRED SIXTY FIVE THOUSAND PESOS (PHP1,665,000.00) TO BE TAKEN FROM THE 20% COMMUNITY DEVELOPMENT FUND - ASSISTANCE TO INFORMAL DWELLERS.

WHEREAS, City Council Resolution No. 09-275, dated 15 April 2009, approved the allocation of Pnp10,000,000.00 for the disqualified families to Southville 3 Housing Project;

WHEREAS, the reasons for disqualification to Southville 3 Housing Project are as follows:

1. Not included in the master list of census families, conducted in 2002-2003;
2. Absentee House Owner (AHO);
3. Moved-out, as per validation survey conducted by NHA in 2006;
4. Out During Census (ODC);
5. Identified project awardee (in government projects);

WHEREAS, the remaining amount of the approved Ten Million Pesos (Pnp10,000,000.00) is Six Million Six Hundred Ninety Thousand Pesos (Pnp6,690,000.00). The total of 3,043 disqualified families in District 1, the 299 families are qualified for the Five Thousand Pesos (Pnp5,000.00) each and the 2,744 families are qualified to get Two Thousand Five Hundred Pesos (Pnp2,500.00) each. Given this data, a total of Eight Million Three Hundred Fifty Five Thousand Pesos (Pnp8,355,000.00) is needed to accommodate each one with the financial support from the Local Government Unit;

WHEREAS, to complete the required amount of **Eight Million Three Hundred Fifty Five Thousand Pesos (Php8,355,000.00)** it is necessary to add **One Million Six Hundred Sixty Five Thousand Pesos (Php1,665,000.00)** to the balance of **Six Million Six Hundred Ninety Thousand Pesos (Php6,690,000.00)** to complete the financial requirements;

WHEREAS, with limited funding available for a big number of families, UPAO opted to adjust the financial assistance to two packages: package 1 – Php5,000.00 each; and Package 2 – Php2,500.00 each;

The criteria are as follows:

Package 1: Php5,000.00

- ✓ Included in the master list of census families
- ✓ Disqualified to Southville 3 Housing Project

Package 2: Php2,500.00

- ✓ Not included in the master list of census families
- ✓ New settlers

WHEREAS, Mr. Avelino Orellana, Budget Officer certified that there is an approved appropriation from 20% Community Development Fund – Assistance to Informal Dwellers in the amount of One Million Seven Hundred Fifty Five Thousand Pesos (Php1,755,000.00);

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to authorize the **Hon. City Mayor Aldrin L. San Pedro** to grant additional financial assistance to disqualified families with a total amount of **One Million Six Hundred Sixty Five Thousand Pesos (Php1,665,000.00)** to be taken from the 20% Community Development Fund – Assistance to Informal Dwellers.
