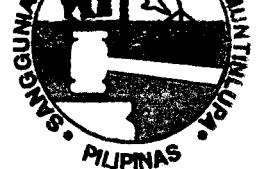

WHEREAS, Section 454(d) of the Republic Act 7160, otherwise known as the Local Government Code of 1991 provides that, *“unless otherwise provided herein, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the Majority of all the Sangguniang Panlungsod members, subject to civil service law, rules and regulations”*. The Sangguniang Panlungsod shall act on the appointment within fifteen (15) days from the date of its submission, otherwise the same shall be deemed confirmed”;

WHEREAS, DR. RAQUEL P. TOLENTINO, was born in Manila, a graduate at the Immaculate Heart of Mary in Quezon City both her primary and secondary education, and in 1994 she graduated Doctor of Dental Medicine at the University of the East College of Dentistry;

WHEREAS, in February 1995, DR. RAQUEL P. TOLENTINO passed the *Board of Dentistry Examination* given by the Professional Regulation Commission (PRC);

WHEREAS, DR. RAQUEL P. TOLENTINO practiced her profession from the time she got her license up to the present;

WHEREAS, DR. RAQUEL P. TOLENTINO, is presently taking up her Masteral Degree in Business Management at the Pamantasan ng Lungsod ng Muntinlupa (PLMun);

WHEREAS, last July 2002, DR. RAQUEL P. TOLENTINO, started working in the City Government of Muntinlupa, as casual (Clerk III) at the Office of the Vice Mayor; from April 2005 to June 2007, was promoted to Community Affairs Officer I at the Drug Abuse Prevention and Control Office (DAPCO);




