**WHEREAS**, Section 458 (a)(1)(iv), of the Local Government Code of 1991 states that, *"the Sangguniang Panlungsod, as the legislative body of the city, shall enact ordinances, xxx and appropriate funds for the general welfare of the city and its inhabitants xxx and shall"*:

**(1)(iv) adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and in the aftermath of said disasters or calamities and their return to productive livelihood following said events.**

**WHEREAS**, on **September 26, 2009** Her Excellency President Gloria Macapagal-Arroyo, through the National Disaster Coordinating Council (NDCC) declared National Capital Region (NCR) and other Provinces as in "state of Calamity due to **"typhoon Ondoy"**";

**WHEREAS**, the City of Muntinlupa is part of the National Capital Region;

**WHEREAS**, there is an overflow of water along the shores of Laguna de Bay that affects the residents of Muntinlupa City, particularly those living along the lakesides, shorelines and creeksides;

**WHEREAS**, big parts of Muntinlupa City are now affected by the overflow of water caused by typhoon "Ondoy";



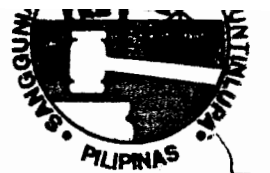

## PROCLAMATION NO 01

### DECLARING A STATE OF NATIONAL CALAMITY


• By virtue of the powers vested in me by law, I, **GILBERTO C. TEODORO JR.**, Secretary, Department of National Defense and Chairman, National Disaster Coordinating Council, do hereby declare a state of national calamity in view of the extensive effects of Typhoon "ONDOY" in the following areas:

- The whole of National Capital Region,
- CAR – Mt Province, Ifugao and Benguet
- Region I - Pangasinan, La Union and Ilocos Sur
- Region II - Isabela, Quirino and Nueva Viscaya
- Region III - Aurora, Nueva Ecija, Zambales, Pampanga, Bulacan, Tarlac and Bataan
- Region IV - Cavite, Laguna, Batangas, Rizal, Quezon
- Region IV-B - Mindoro Occidental, Mindoro Oriental and Marinduque
- Region V - Catanduanes, Camarines Norte and Camarines Sur

All departments and other government agencies concerned are hereby directed to implement and execute medical assistance, relief and rehabilitation work in accordance with existing operational plans, directives and orders issued in connection with the occurrence of calamities.
