**WHEREAS**, the recent Tropical Storm "**Ondoy**" that hit the country on September 26, wreak havoc in many parts of the country mainly in Metro Manila and Rizal claiming many lives and causing destruction resulting from devastating floods;

**WHEREAS**, Muntinlupa being one of the Cities badly affected by the incessant rains which caused flooding in its eight (8) Barangays situated along the shorelines of the Laguna de Bay;

**WHEREAS**, while the City Government has responded to the urgent needs of affected and displaced families, the City's capacities have its limitations;

**WHEREAS**, with the massive scale of damages to property the recovery of the city is expected to take a long process and has estimated that it would take several months to reconstruct and rehabilitate public facilities primarily the school buildings some of which were financed by the term loans incurred by the city;

**WHEREAS**, the City Government would like to seek the assistance and with the banking institution in restructuring its loans, a moratorium on its liabilities and we are willing to accept any favorable terms and conditions to the City Government until such time that the City Government fully recovers from the said major national disaster;

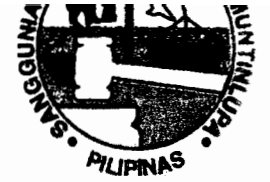




