WHEREAS, Section 458 (a) (1) (i) of Republic Act 7160, otherwise known as the Local Government Code of 1991 empowers the Sanggunian Panlungsod to review all ordinances approved by the Sangguniang Barangay and execute orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay;

WHEREAS, Section 458 (a) (5) (xvii) of the same Code provides that the Sangguniang Panlungsod shall adopt measure mutually beneficial to the elderly and to the community;

WHEREAS, Article XV, Section 4 of the Philippine Constitution further states that "the Family has the duty to care for its elderly members, but the State may also do so through just programs of social security;

WHEREAS, on September 8, 2009, *Hon. Barangay Chairman Ruben P. Baes* of *Barangay Ayala-Alabang* transmitted a letter to the Chairman of the Committee on Barangay Affairs forwarding its **Ordinance No. 09-003** for review of the Sangguniang Panlungsod entitled, "an ordinance providing for recognition of Senior Citizens who has reached the age of seventy five (75) to be known as the Diamond Award" with cash gift in the amount of Two Thousand Pesos (Php2,000.00) and appropriating funds thereof";
