WHEREAS, as representative of the Council to the League **Hon. Coun. Atty. Raul R. Corro**, was elected as Director of **Metro Manila Councilor's League (MMPCL)** in 1998-2001, appointed **Legal Counsel** of the **Philippine Councilor's League, National Capital Region (PCL-NCR)**, Chairman of the Awards Committee in the PCL National Congress and was elected as **Chairman** of the **MMPCL** in 2004-2007;




