**A RESOLUTION APPROVING THE AMENDMENTS IN BARANGAY ORDINANCE NO. 06-022, SERIES OF 2010 OF BARANGAY AYALA-ALABANG, OTHERWISE KNOWN AS AN ORDINANCE GRANTING ADDITIONAL BENEFITS TO CITIZENS WHO REACHED THE AGE OF SIXTY (60) UP TO SEVENTY FOUR (74) YEARS OLD ON THEIR BIRTHDAY TO BE KNOWN AS THE SENIOR CITIZEN AWARD WITH CASH GIFT IN THE AMOUNT OF ONE THOUSAND PESOS (PHP1,000.00) AND APPROPRIATING THE FUNDS FROM UNEXPENDED BALANCE OF GENDER DEVELOPMENT FUND OF AYALA ALABANG.**

**WHEREAS**, Section 458 (a) (1) (i) of Republic Act 7160, otherwise known as the Local Government Code of 1991, ***“empowers the Sanggunian Panlungsod to review all ordinances approved by the Sangguniang Barangay and Executive Orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and the Punongbarangay”***;

**WHEREAS**, Section 458 (a) (5) (xvii) of the same Code provides that, ***“the Sangguniang Panlungsod shall formulate policies and adopt measures mutually beneficial to the elderly and the community”***;

**WHEREAS**, Article XV, Section 4 of the Philippine Constitution further states that, ***“the family has the duty to take care of its elderly members, but the State may also do so through just programs of social security”***;

**WHEREAS**, on August 12, 2010, *Hon. Barangay Chairman Ruben P. Baes of Barangay Ayala Alabang* forwarded a letter to the Sangguniang Panlungsod requesting for review/approval of its Ordinance No. 06-002, Series of 2010 as ***“An ordinance amending Barangay Ordinance No. 09-003, series of 2009, otherwise known as an ordinance granting additional benefits to Senior Citizens who reached the age of sixty (60) up to seventy four (74) years old on their birthday to be known as the Senior Citizen Award with a cash gift in the amount of One Thousand Pesos (Php1,000.00) and appropriating the funds thereof”***;






