RESOLUTION NO. 10-018

A RESOLUTION REQUIRING THE FIRST PHILIPPINE INDUSTRIAL CORPORATION (FPIC) TO CONDUCT IMMEDIATE PHYSICAL INSPECTION OF ITS PIPELINES WITHIN THE AREA OF MUNTINLUPA CITY ON/OR BEFORE DECEMBER 2010 TO PROTECT THE PEOPLE FROM THE PROBABLE HARMFUL EFFECTS OF ITS PIPELINES RUNNING THROUGH THE ENTIRE LENGTH OF THE CITY.

WHEREAS, Article 99 (1) (iv) of Rules and Regulations Implementing the Local Government Code of 1991, states that, "the Sangguniang Panlungsod as the legislative body of the city, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural calamities and disasters, xxx.";

WHEREAS, the First Philippine Industrial Corporation (FPIC) owns and maintains an existing 117 kilometers gas pipelines part of which traverse the entire length of the City of Muntinlupa;

WHEREAS, on June 10, 1999 there was, in fact, a leak in the pipeline in the Pasong Diablo Alabang portion which caused a fire that gutted 140 houses at the boundary of Barangays Alabang and Cupang where the pipelines are located;

WHEREAS, the possibility of occurrence of another man-made calamity is very imminent, for Muntinlupa lies along the active-moving Marikina Valley Fault Zone on the same path of the 40-year old pipelines;

WHEREAS, incidents associated with gas leaks are controllable and may be deterred by regular inspection of "First Philippine Industrial Corporation" pipes;

WHEREAS, the City Mayor Hon. Aldrin L. San Pedro, requested the City Council to pass a resolution requiring the FPIC to inspect the entire stretch of its pipeline for possible leaks to ensure that the oil leak which happened in Makati City will not happen in other areas especially in Muntinlupa City;

**WHEREAS**, as per inspection of FPIC, it found five rice grain sized holes in a portion of its pipeline located in Makati City and believed to be the source of the oil that had been leaking into the basement of the nearby West Tower Condominium since July 12, 2010;

**WHEREAS**, Muntinlupa lies along the **Marikina Valley Fault Zone** and more than nine (9) kilometers of the FPIC pipelines traverses the same path and such fault line is actively moving within the area;

**WHEREAS**, the City Mayor and other officials of the City Government don't want anymore incident similar to what happened on June 10, 1999 and in Makati City, hence the decision to require the FPIC to conduct inspection of its pipelines that traverse the jurisdiction of Muntinlupa;

**NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa, in session assembled, to require the **First Philippine Industrial Corporation (FPIC)** to conduct immediate physical inspection of its pipelines within the area of Muntinlupa City on/or before **December 2010** to protect the people from the probable harmful effects of its pipelines running through the entire length of the city.

**APPROVED**, by the 6<sup>th</sup> **Sangguniang Panlungsod of Muntinlupa** this 15<sup>th</sup> day of **November 2010**, on its 16<sup>th</sup> **Regular Session**.
