A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO TO ENTER INTO A NEW CONTRACT IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH EXPEDITION CONSTRUCTION CORPORATION FOR GARBAGE COLLECTION AND DISPOSAL SERVICES FOR THE YEAR 2010 IN THE AMOUNT OF FOURTEEN MILLION PESOS (Php 14,00,000.00) PER MONTH OR WITH TOTAL AMOUNT OF ONE HUNDRED SIXTY EIGHT MILLION PESOS (Php168,000,000.00) FOR A PERIOD OF ONE YEAR TO BE TAKEN FROM THE 2010 EXECUTIVE BUDGET.

WHEREAS, one of the priority programs of the City Government of Muntinlupa is the improvement of garbage collection and disposal services in order to ensure the cleanliness of the city;

WHEREAS, in order to attain this objective and in view of the expiration of the previous garbage collection and disposal contract, the City Government of Muntinlupa has caused the procurement of said contract through open and competitive bidding in accordance with the provisions of Republic Act No. 9184 or the Government Procurement Reform Act;

WHEREAS, the City Government of Muntinlupa advertised the Invitation to apply for Eligibility and to Bid of the Contract for Garbage Collection and Disposal Services of the City of Muntinlupa for the year 2010 in a newspaper of nationwide general circulation and posted the same in the conspicuous place at the premises of the City Hall of Muntinlupa continuously for seven (7) days;

WHEREAS, in response to the said advertisements, three (3) contractors submitted letters of intent and applications for eligibility and the three (3) were found eligible;

WHEREAS, three bids were submitted on December 15, 2009 and the bid passed the preliminary examination of bids;

WHEREAS, the detailed evaluation of bids conducted on December 16, 2009 resulted in the following:

WHEREAS, upon post-qualification and careful examination, evaluation and verification of the eligibility, technical and financial requirements submitted by the three (3) bidders with the calculated bid, the EXPEDITION Construction Corporation was found to be responsive;

WHEREAS, the Bids and Awards Committee declared Expedition Construction Corporation as the winning bidder for the contract for garbage collection and disposal services of the City of Muntinlupa for the FY 2010;

WHEREAS, in the public bidding that was conducted by the Bids and Awards Committee (BAC) the bid proposal by the EXPEDITION was found to be the Lowest Calculated and Responsive Bid (LCRB) for which a Notice of Award has been issued by the City Mayor;

WHEREAS, the said contract shall be effective from the date of signing hereof;

WHEREAS, there is a budget appropriated for the garbage collection and disposal services amounting to **One Hundred Sixty Nine Million Pesos (Php169,000,000.00)** under the 2010 Executive Budget as certified by the Budget Officer;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to authorize the Hon. City Mayor Aldrin L. San Pedro to enter into a new Contract in behalf of the City Government of Muntinlupa with Expedition Construction Corporation for Garbage Collection and Disposal Services for the year 2010 in the amount of Fourteen Million Pesos (Php 14,00,000.00) per month or with total amount of One Hundred Sixty Eight Million Pesos (Php168,000,000.00) for a period of one year to be taken from the 2010 Executive Budget.

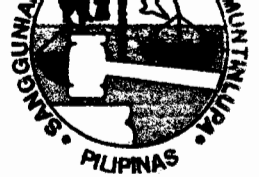



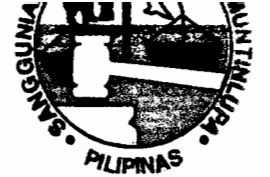
