WHEREAS, Rule V, Article 25, paragraph D(1), Republic Act 7160, otherwise known as the Rules and Regulations Implementing the Local Government Code of 1991, states that, ***“the Local Government Unit (LGU) shall, in addition to their existing functions and responsibilities, provide basic services and facilities devolved to them covering, but not limited to the following:***

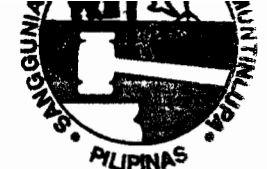
(d) Provision of social welfare services through:

WHEREAS, pursuant to Section 76 of RA 9184 states that, "any other law, presidential decree or issuance, executive order, letter of instruction, administrative order, proclamation, charter, rule or regulations and/or parts thereof contrary to or inconsistent with the provisions of this Act is hereby repealed, modified or amended accordingly;

WHEREAS, however to further enhance transparency and accountability the Executive Department thru BAC submitted the project to the City Council for ratification;

WHEREAS, the City Government of Muntinlupa purchased 40,000 pieces trolley bags in the amount of Php22,00,000.00 and was bid on April 30, 2008 intended for pre-school and grade school pupils of different public schools of the city;

WHEREAS, one of the priority projects of the City Government is to distribute free bags to pre-school and grade school pupils in different public schools within the City;

WHEREAS, there is a need to approve, confirm and ratify the said projects of the city government for the benefit of the public;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **5th Sangguniang Panlungsod of Muntinlupa**, to ratify, confirm and approve the purchase of 40,000 pieces Trolley Bags amounting to **Twenty Two Million Pesos (Php22,000,000.00)** taken from the Special Activities Fund (SAF) and Social Amelioration (SA) of the City Mayor intended for pre-school and grade school pupils of our City.
