WHEREAS, the City Mayor Hon. Aldrin L. San Pedro seeks an authority from the Sangguniang Panglungsod of Muntinlupa, as legislative body, to sign the extension of contract with Expedition Corporation for the garbage hauling and disposal services within the jurisdiction of the City of Muntinlupa;

WHEREAS, Republic Act 9184, otherwise known as the "Government Procurement Act" and its Implementing Rules and Regulations Part A (IRR-A) took effect on January 26, 2003 and October 8, 2003, respectively;

WHEREAS, Section 22(c) of Republic Act 7160, otherwise known as the Local Government Code of 1991, states that, **"every local government unit, as a corporate shall xxx unless otherwise provided in this Code, no contract maybe entered into by the local Chief Executive in behalf of the local government unit without prior authorization by the Sanggunian concerned"**;

WHEREAS, the extension of ongoing contracts of general supports services is allowed for the purpose of averting hiatus in the delivery of support services essential, indispensable, or necessary in the operations of a procuring entity;

WHEREAS, the extension of the contract is merely an emergency measure to maintain the cleanliness of the entire city and to prevent epidemic that maybe caused by the garbage if not collected;

WHEREAS, the aforesaid contract extension is undertaken due to circumstances beyond its control and the procuring entity concerned cannot award a new contract within a month after the expiration of the term of the original contract;

WHEREAS, the Bid and Awards Committee (BAC) of the City approved BAC Resolution Numbers 2009-010-018; 2009-007-091 and 2009-004-001 recommending the approval of the extension of contract with Expedition Construction Corporation for garbage hauling and disposal services under the same terms and conditions of the original contract at a contract price of **Ten Million Eight Hundred Seven Thousand Eighty-Three Pesos and Thirty-Three Centavos (Php10,807,083.33)** per month;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 5th Sangguniang Panlungsod of Muntinlupa to confirm and ratify the extension of contract of Expedition Corporation for the garbage hauling and disposal services within the City of Muntinlupa thru Hon. City Mayor Aldrin L. San Pedro for the following period: from **May 1 to July 31, 2009, August 1 to September 30, 2009, October 1 to December 31, 2009** by virtue of BAC Resolution Numbers 2009-010-018; 2009-007-091 and 2009-004-001.

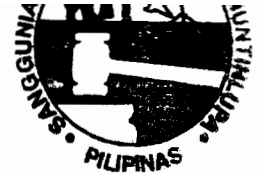


