WHEREAS, the City Government is the legal owner of a parcel of land with an estimated area of 3,118 square meters, more or less, a portion of which is covered by **TCT No. 211898** issued by the **Registry of Deeds of Muntinlupa** acquired for socialized housing purposes;

WHEREAS, the **City Government of Muntinlupa**, which is undertaking a comprehensive and continuing urban development and pro-poor housing program, desires to develop the said parcel of land for socialized housing purposes with technical and financing assistance from other government line agencies and the private sector;

WHEREAS, the City Government of Muntinlupa aims to provide its low-salaried employees with decent and affordable homes in order to uplift the living condition of all its constituents, in sync with the comprehensive plan to promote development in the City of Muntinlupa;

WHEREAS, low-salaried employees above-mentioned are those whose income fall within the range of **salary grade 12 below** and not owners of a lot and/or a house in the city or in the province;

WHEREAS, the Gawad Kalinga Community Development Foundation, Inc., (GKCDFI) has signified its interest and willingness to support the national and local government's effort to provide decent housing, basic services, employment and livelihood opportunities to the urban poor constituents of the City of Muntinlupa;
