A RESOLUTION RATIFYING THE CONTRACT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH EXPEDITION CONSTRUCTION CORPORATION FOR THE GARBAGE HAULING AND DISPOSAL SERVICES FOR THE PEOPLE OF MUNTINLUPA IN THE AMOUNT OF ONE HUNDRED SIXTY SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP167,500,000.00) WHICH AMOUNT SHALL BE TAKEN FROM THE 2010 EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, in pursuit of transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod a letter dated 04 March 2011 wherein written are the proposed list of infrastructure and general service project, including the garbage hauling and disposal services to be undertaken by the City Government;

WHEREAS, garbage hauling and disposal services is critical component of the general services due the people of Muntinlupa;

WHEREAS, a CONTRACT was executed between the City Government of Muntinlupa and Expedition Construction Corporation for the garbage hauling and disposal services, dated 22 December 2009, in the amount of One Hundred Sixty Seven Million Five Hundred Thousand Pesos (Php167,500,000.00) as a result of the public bidding conducted for such purpose by the Bids and Awards Committee (BAC) on 15 December 2009,

San Pedro**, in behalf of the City Government of Muntinlupa with **Expedition Construction Corporation** for the garbage hauling and disposal services for the people of Muntinlupa in the amount of **One Hundred Sixty Seven Million Five Hundred Thousand Pesos (Php167,500,000.00)** which amount shall be taken from the 2010 Executive Budget.

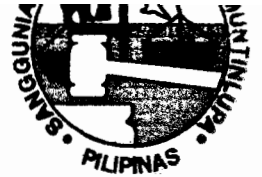
