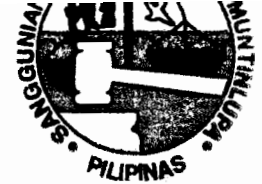

WHEREAS, on April 14, 2009, the City Government of Muntinlupa entered into Construction Agreement with VF Labao Construction for the construction of the project **Day Care Center Site # 4** amounting to Four Million Three Hundred Forty Two Thousand One Peso And Twelve Centavos (PHP4,342,001.12) as a result of a public bidding held on March 31, 2009;

WHEREAS, on April 6, 2009, the Bids and Awards Committee (BAC) approved **Resolution No. 03-029**, "declaring the VF Labao Construction as the bidder with the Lowest Calculated Responsive Bid for the construction of **Day Care Center Site # 4** at NHA Resettlement Project, NBP Poblacion, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the **Supreme Court** (SC) decision, there is a need for the Sangguniang Panlungsod to *ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the **6th Sangguniang Panlungsod**, to ratify the Construction Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **VF Labao Construction** for the project **Day Care Center Site # 4** located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City in the amount of **Four Million Three Hundred Forty Two Thousand One Peso and Twelve Centavos (PHP4,342,001.12)**.
