WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

WHEREAS, the construction of **Day Care Center Site # 5** located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on April 14, 2009, the City Government of Muntinlupa entered into Construction Agreement with VF Labao Construction for the construction of the project **Day Care Center Site # 5** amounting to Four Million One Hundred Thirty Four Thousand Six Hundred Twenty Seven Pesos and Fifty Seven Centavos (Php4,134,627.57) as a result of a public bidding held on March 31, 2009;
