**WHEREAS**, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

**WHEREAS**, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the Construction Agreement for ratification;

**WHEREAS**, the construction of **Day Care Center Site # 12** located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

**WHEREAS**, on April 14, 2009, the City Government of Muntinlupa entered into Construction Agreement with JBA Espejo Construction Corporation for the construction of the project **Day Care Center Site # 12** amounting to Four Million One Hundred Thirty Four Thousand Nine Hundred Thirty Pesos and Fifty Six Centavos (Php4,134,930.56) as a result of a public bidding held on March 31, 2009;

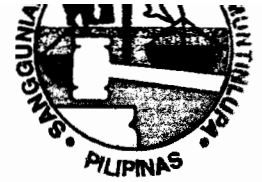

**WHEREAS**, pursuant to the **Supreme Court** (SC) decision, there is a need for the Sangguniang Panlungsod to ratify contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **6<sup>th</sup> Sangguniang Panlungsod**, to ratify the Construction Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **Day Care Center Site # 12** located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City in the amount of **Four Million One Hundred Thirty Four Thousand Nine Hundred Thirty Pesos and Fifty Six Centavos (Php4,134,930.56)**.

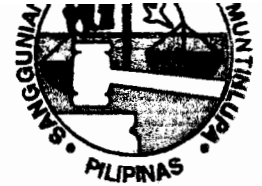


