A RESOLUTION RATIFYING THE CONTRACT AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH SOCOR CONTRACT CORPORATION FOR THE PAINTING OF THERMOPLASTIC LANE MARKINGS LOCATED AT MUNTINLUPA-SAN PEDRO BOUNDARY GOING TO ALABANG-LAS PIÑAS BOUNDARY/SUSANA HEIGHTS, TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TWENTY NINE MILLION FIVE HUNDRED NINETY EIGHT THOUSAND EIGHT HUNDRED FOUR PESOS AND TWENTY CENTAVOS (PHP29,598,804.20).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **CONTRACT Agreement** for ratification;

WHEREAS, the **contract** of proposed painting of thermoplastic lane markings located at Muntinlupa-San Pedro Boundary going to Alabang-Las Piñas boundary/Susana Heights, Tunasan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, the City Government of Muntinlupa entered into **CONTRACT Agreement** with Socor **Construction** Corporation for the **CONTRACT** of the project painting of thermoplastic lane markings amounting to Twenty Nine Million Five Hundred Ninety Eight Thousand Eight Hundred Four Pesos and Twenty Centavos (Php29,598,804.20) as a result of a public bidding held on **May 5, 2008**;

WHEREAS, the Contract Agreement in consideration of the payments to be made by the City Government to Socor Construction Corporation as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on **May 5, 2008**, the Bids and Awards Committee (BAC) approved **Resolution No. 04-030**, "declaring the Socor Construction Corporation as the bidder with the Lowest Calculated Responsive Bid for the contract of painting of thermoplastic lane markings at Muntinlupa-San Pedro Boundary going to Alabang-Las Piñas boundary/Susana Heights, Tunasan, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the **Supreme Court** (SC) decision, there is a need for the Sangguniang Panlungsod to *ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Contract Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **Socor Construction Corporation** for the painting of thermoplastic lane markings located at Muntinlupa-San Pedro Boundary going to Alabang-Las Piñas boundary/Susana Heights, Tunasan, Muntinlupa City In the amount of **Twenty Nine Million Five Hundred Ninety Eight Thousand Eight Hundred Four Pesos and Twenty Centavos (Php29,598,804.20)**.
