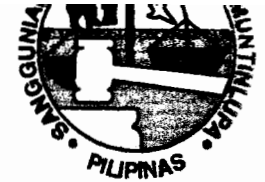

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "***the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances***";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of **rehabilitation of City Hall (Phase 2) Muntinlupa City** located at National Road, Putatan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on **May 15, 208**, the City Government of Muntinlupa entered into Construction Agreement with **Expedition Construction Corporation** for the construction of the project **rehabilitation of City Hall (Phase 2) Muntinlupa City** amounting to **Twenty One Million Six Thousand Eight Hundred Forty Pesos and Twenty Four Centavos (Php21,006,840.24)** as a result of a public bidding held on **May 6, 2008**;

**WHEREAS**, pursuant to the **Supreme Court** (SC) decision, there is a need for the Sangguniang Panlungsod to *ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 6<sup>th</sup> Sangguniang Panlungsod to ratify the Construction Agreement entered into by the **City Mayor Hon. Aldrin L. San Pedro**, in behalf of the City Government of Muntinlupa with **Expedition Construction Corporation** for the project **rehabilitation of City Hall (Phase 2) Muntinlupa City** located at National Road, Putatan, Muntinlupa City in the amount of **Twenty One Million Six Thousand Eight Hundred Forty Pesos and Twenty Four Centavos (Php21,006,840.24)**.


