WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, ***“the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances”***;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of **Day Care Center Site # 8** located at National Road, Putatan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on April 10, 2009, the City Government of Muntinlupa entered into Construction Agreement with **PDJ** Integrated Construction for the construction of the project **Day Care Center Site # 8** amounting to Four Million One Hundred Thirty Four Thousand Eight Hundred Twenty Three and Forty Three Centavos (Php4,134,823.43) as a result of a public bidding held on **April 1, 2009**;

WHEREAS, on **April 6, 2009**, the Bids and Awards Committee (BAC) approved **Resolution No. 04-037**, "declaring the **PDJ Integrated Construction** as the bidder with the Lowest Calculated Responsive Bid for the construction of **Day Care Center Site # 8** at NHA Resettlement Project, NBP Poblacion, Muntinlupa City and recommend the approval by the City Mayor;



San Pedro**, in behalf of the City Government of Muntinlupa with **PDJ Integrated Construction** for the project **Day Care Center Site # 8** located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City in the amount of **Four Million One Hundred Thirty Four Thousand Eight Hundred Twenty Three and Forty Three Centavos (Php4,134,823.43)**.


