A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT DRAINAGE LOCATED AT LAKEVIEW I SUBDIVISION, PUTATAN, MUNTINLUPA CITY IN THE AMOUNT OF FIVE MILLION FIVE HUNDRED SIXTY SIX THOUSAND ONE HUNDRED FIFTY PESOS AND SEVENTY FOUR CENTAVOS (PHP5,566,115.74).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "*the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances*";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of **Drainage** located at Lakeview I Subdivision, Putatan, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on April 7, 2009, the City Government of Muntinlupa entered into Construction Agreement with PDJ Integrated Construction for the construction of the project **Drainage** amounting to Lakeview I Subdivision, Putatan, Muntinlupa City in the amount of Five Million Five Hundred Sixty Six Thousand One Hundred Fifty Pesos and Seventy Four Centavos (Php5,566,115.74) as a result of a public bidding held on **March 31, 2009**;

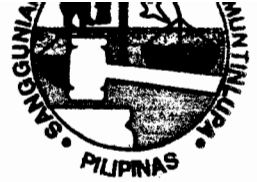

WHEREAS, the Bids and Awards Committee (BAC) approved Resolution No. 03-045, "declaring the PDJ Integrated Construction as the bidder with the Lowest Calculated Responsive Bid for the construction of Drainage at Lakeview I Subdivision, Putatan, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the Supreme Court (SC) decision, there is a need for the Sangguniang Panlungsod to ratify contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with PDJ Integrated Construction for the project Drainage located at Lakeview I Subdivision, Putatan, Muntinlupa City in the amount of Five Million Five Hundred Sixty Six Thousand One Hundred Fifty Pesos and Seventy Four Centavos (Php5,566,115.74).

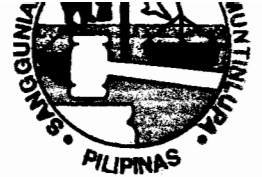


