SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH PDJ INTEGRATED CONSTRUCTION FOR THE PROJECT POLICE STATION LOCATED AT NHA RESETTLEMENT PROJECT, NBP POBLACION, MUNTINLUPA CITY IN THE AMOUNT OF TWO MILLION FOUR HUNDRED FIFTY NINE THOUSAND NINE HUNDRED NINETY FOUR PESOS AND FORTY FOUR CENTAVOS (PHP2,459,994.44).

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of Police Station located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on April 14, 2009, the City Government of Muntinlupa entered into Construction Agreement with PDJ Integrated Construction for the construction of the project Police Station amounting to Two Million Four Hundred Fifty Nine Thousand Nine Hundred Ninety Four Pesos and Forty Four Centavos (Php2,459,994.44) as a result of a public bidding held on April 1, 2009:

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to PDJ Integrated Construction as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on April 2, 2009, the Bids and Awards Committee (BAC) approved Resolution No. 03-045, "declaring the PDJ Integrated Construction as the bidder with the Lowest Calculated Responsive Bid for the construction of Police Station at NHA Resettlement Project, NBP Poblacion, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the Supreme Court (SC) decision, there is a need for the Sangguniang Panlungsod to ratify contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with PDJ Integrated Construction for the project Police Station located at NHA Resettlement Project, NBP Poblacion, Muntinlupa City in the amount of Two Million Four Hundred Fifty Nine Thousand Nine Hundred Ninety Four Pesos and Forty Four Centavos (Php2,459,994.44).


