WHEREAS, the Land Bank of the Philippines (LBP) offered a loan facility for the elected officials and regular employees of the City Government of Muntinlupa;

WHEREAS, the terms and conditions were indicated in a *Memorandum* of *Agreement (MOA)* submitted by *Land Bank* of the *Philippines* and were found to be beneficial to ease the financial needs of the borrower – employee;

WHEREAS, the loan facility offered by Land Bank of the Philippines (LBP) is not prejudicial to both parties;
