A RESOLUTION AUTHORIZING THE HON. CITY MAYOR ALDRIN L. SAN PEDRO IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA TO SIGN THE MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF JUSTICE (DOJ) IN CONNECTION WITH THE ELECTRICAL OBLIGATION OF THE DEPARTMENT OF JUSTICE (DOJ) AND ALLOCATING THE AMOUNT OF FOUR HUNDRED EIGHTY FIVE THOUSAND TWO HUNDRED SIXTY NINE PESOS (PHP485,269.00) REPRESENTING THE SHARE OF THE CITY GOVERNMENT IN THE CONTRIBUTION IN AID OF CONSTRUCTION COST (CIAC) WHICH SHALL BE TAKEN FROM ANY AVAILABLE FUND IN THE EXECUTIVE BUDGET.

**WHEREAS**, in pursuance to the said policy, the City Government of Muntinlupa in coordination with the Department of Justice, constructed the Muntinlupa Justice Hall at Tunasan, Muntinlupa City which had its opening/turn-over ceremonies last **March 2, 2011**;

**WHEREAS**, a permanent **service electric connection** of the **Muntinlupa City Hall of Justice** is urgent so as to facilitate the transfer of all Courts housed and scattered in different buildings within the city to the said structure;

**WHEREAS**, the cost of permanent service electric connection amounted to **One Million Nine Hundred Ninety Two Thousand Nineteen Pesos (Php1,992,019.00)**;

**WHEREAS**, the Department of Justice (DOJ) has an available amount of One Million Five Hundred Six Thousand Seven Hundred Fifty Pesos (Php1,506,750.00) to fund the permanent service electric connection and is short of **Four Hundred Eighty Five Thousand Two Hundred Sixty Nine Pesos** (Php485,269.00);

**WHEREAS**, in a special meeting held on **04 April 2011** at the **Supreme Court of Manila**, it was agreed that the City Government of Muntinlupa will provide the additional funding requirement of **Four Hundred Eighty Five Thousand Two Hundred Sixty Nine Pesos** (Php485,269.00) to augment the Department of Justice (DOJ) fund of One Million Five Hundred Six Thousand Seven Hundred Fifty Pesos (Php1,506,750.00) for the **Contribution in Aid of Construction Cost (CIAC)**;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the **6<sup>th</sup> Sangguniang Panlungsod of Muntinlupa**, to authorize the **Hon. City Mayor Aldrin L. San Pedro** in behalf of the City Government of Muntinlupa to sign the **Memorandum of Agreement (MOA)** with the **Department of Justice (DOJ)** in connection with the electrical obligation of the Department of Justice (DOJ) and allocating the amount of **Four Hundred Eighty Five Thousand Two Hundred Sixty Nine Pesos (Php485,269.00)** representing the share of the city government in the Construction In Aid of Construction Cost (CIAC) which shall be taken from any available fund in the Executive Budget.
