(a) shall review all ordinances approved by the Sangguniang Barangay and executive orders issued by the Punongbarangay to determine whether these are within the scope of the prescribed powers of the Sanggunian and of the Punongbarangay”;

WHEREAS, Barangay AYALA-ALABANG has a total budget of THIRTY EIGHT MILLION NINE HUNDRED SEVENTY SEVEN THOUSAND THREE HUNDRED FORTY FIVE PESOS (PHP38,977,345.00) as per Appropriation Ordinance No. 01-2011, Series of 2011;

WHEREAS, the total appropriation for **Personal Services (PS)** of Barangay AYALA-ALABANG does **not exceed** the **55% limitation** set under Article 423(d) of the Implementing Rules and Regulations of the Local Government Code of 1991 and Local Budget Memorandum Circular No. 53, dated June 29, 2007;

WHEREAS, the said Appropriation Ordinance was reviewed by the **City Budget Office** and was found to be **proper and in order**, having complied with the requirements setforth under the Local Government Code of 1991;
