SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH ASRO CONSTRUCTION & TRADING FOR REHABILITATION/REPAIR LOCATED AT SUCAT ELEMENTARY SCHOOL, BARANGAY SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF THREE MILLION FIVE HUNDRED SEVENTY ONE THOUSAND EIGHT EIGHTY THREE PESOS AND 76/100 (PHP3,571,883.76) WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 SUPPLEMENTAL BUDGET NO. 1 - INFRASTRUCTURE PROJECT UNDER THE EXECUTIVE BUDGET.

**WHEREAS**, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "*the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances*";

**WHEREAS**, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

**WHEREAS**, the rehabilitation/repair of one storey school building located at Sucat Elementary School, Barangay Sucat, Muntinlupa City is one of the priority projects of the City Government of Muntinlupa;

**WHEREAS**, on **March 17, 2010**, the City Government of Muntinlupa entered into Construction Agreement with ASRO Construction & Trading for the construction of the project amounting to **THREE MILLION FIVE HUNDRED SEVENTY ONE THOUSAND EIGHT EIGHTY THREE PESOS AND 76/100 (PHP3,571,883.76)** as a result of a public bidding held on **March 9, 2010**;

**WHEREAS**, the Construction Agreement in consideration of the payments to be made by the City Government to ASRO Construction & Trading as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, pursuant to the **Supreme Court (SC)** decision, there is a need for the Sangguniang Panlungsod *to ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, by the 6<sup>th</sup> Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with ASRO Construction & Trading for rehabilitation/repair of one storey school building located at Sucat Elementary School, Barangay Sucat, Muntinlupa City, in the amount of **THREE MILLION FIVE HUNDRED SEVENTY ONE THOUSAND EIGHT EIGHTY THREE PESOS AND 76/100 (PHP3,571,883.76)** which amount shall be taken from the 2008 Supplemental Budget No. 1 - Infrastructure Project under the Executive Budget.
