A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH ASRO CONSTRUCTION & TRADING FOR THE PROJECT CONSTRUCTION OF BASKETBALL COURT LOCATED AT SITIO BAGONG SILANG, BARANGAY SUCAT, MUNTINLUPA CITY IN THE AMOUNT OF NINE HUNDRED SIXTY FOUR THOUSAND NINE HUNDRED SIXTY THREE PESOS AND 08/100 (PHP964,963.08) WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 SUPPLEMENTAL BUDGET NO. 1 - INFRASTRUCTURE PROJECT UNDER THE EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, *"the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances"*;

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the **Construction of Basketball Court** located at **Bagong Silang, Barangay Sucat, Muntinlupa City** is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on **March 16, 2010**, the City Government of Muntinlupa entered into Construction Agreement with **ASRO Construction & Trading** for the construction of the project amounting to **NINE HUNDRED SIXTY FOUR THOUSAND NINE HUNDRED SIXTY THREE PESOS AND 08/100 (PHP964,963.08)** as a result of a public bidding held on **March 9, 2010**;

WHEREAS, on **March 11, 2010**, the Bids and Awards Committee (BAC) approved Resolution No. 1-03-012-10, "declaring the Asro Construction & Trading as the bidder with the Lowest Calculated Responsive Bid for the Construction of Basketball Court located at Bagong Silang, Barangay Sucat, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the **Supreme Court (SC)** decision, there is a need for the Sangguniang Panlungsod to *ratify* contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with ASRO Construction & Trading for the construction of Basketball Court located at Bagong Silang, Barangay Sucat, Muntinlupa City, in the amount of **NINE HUNDRED SIXTY FOUR THOUSAND NINE HUNDRED SIXTY THREE PESOS AND 08/100 (PHP964,963.08)** which amount shall be taken from the 2008 Supplemental Budget No. 1 - Infrastructure Project under the Executive Budget.
