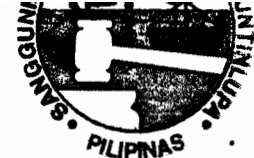

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to Expedition Construction Corporation as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on August 4, 2008, the Bids and Awards Committee (BAC) approved Resolution No. 08-016, declaring the Expedition Construction Corporation as the bidder with the Lowest Calculated Responsive Bid for the improvement of sidewalk, installation of street lights and construction of plant boxes and railings and recommend the approval by the City Mayor;

WHEREAS, pursuant to the Supreme Court (SC) decision, there is a need for the Sangguniang Panlungsod to ratify contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with Expedition Construction Corporation for the improvement of sidewalk, installation of street lights and construction of plant boxes and railings located at Alabang Viaduct, Alabang, Muntinlupa City in the amount of Nineteen Million Nine Hundred Fifty Thousand Forty Eight Pesos and 80/100 (PHP19,950,048.80) which amount shall be taken from the Infrastructure Project under the Executive Budget.


