RESOLUTION NO. 11-091

A RESOLUTION RATIFYING THE CONSTRUCTION AGREEMENT ENTERED INTO BY THE CITY MAYOR HON. ALDRIN L. SAN PEDRO, IN BEHALF OF THE CITY GOVERNMENT OF MUNTINLUPA WITH AP MELENDREZ CONSTRUCTION FOR THE PROJECT ROAD CONCRETING, DRAINAGE, SIDEWALK CURVE AND GUTTER, STREETLIGHTS, PAVING BLOCKS AND PARKING AREA LOCATED AT MUNTINLUPA CITY HALL OF JUSTICE, NATIONAL ROAD, BARANGAY TUNASAN, MUNTINLUPA CITY IN THE AMOUNT OF TEN MILLION EIGHT HUNDRED EIGHTY SIX THOUSAND SIX HUNDRED SIXTEEN PESOS AND 04/100 (PHP10,886,616.04) WHICH AMOUNT SHALL BE TAKEN FROM THE 2008 SUPPLEMENTAL BUDGET NO. 1 - INFRASTRUCTURE PROJECT UNDER THE EXECUTIVE BUDGET.

WHEREAS, Article 86 (b)(1)(vi) and Article 86 (b)(1)(viii) of the Local Government Code of 1991, provides that, "the City Mayor may represent the city in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or ordinances";

WHEREAS, to further enhance transparency and accountability the Hon. City Mayor Aldrin L. San Pedro submitted to the Sangguniang Panlungsod the **Construction Agreement** for ratification;

WHEREAS, the construction of road concreting, drainage, sidewalk curb and gutter, streetlights, paving blocks and parking area located at *Muntinlupa City Hall of Justice, National Road, Barangay Tunasan, Muntinlupa City* is one of the priority projects of the City Government of Muntinlupa;

WHEREAS, on January 19, 2011, the City Government of Muntinlupa entered into Construction Agreement with AP Melendrez Construction, Inc., for the construction of the project amounting to Ten Million Eight Hundred Eighty Six Thousand Six Hundred Sixteen Pesos and 04/100 (PHP10,886,616.04) as a result of a public bidding held on January 13, 2011;

WHEREAS, the Construction Agreement in consideration of the payments to be made by the City Government to AP Melendrez Construction, Inc., as winning bidder, the contractor undertakes to execute and complete the works and remedy any defects therein in conformity with the provisions of the said contract in all aspects;

WHEREAS, on January 18, 2011, the Bids and Awards Committee (BAC) approved Resolution No. 1-01-001-11, "declaring the AP Melendrez Construction, Inc., as the bidder with the Lowest Calculated Responsive Bid for the road concreting, drainage, sidewalk curb and gutter, streetlights, paving blocks and parking area located at Muntinlupa City Hall of Justice, National Road, Barangay Tunasan, Muntinlupa City and recommend the approval by the City Mayor;

WHEREAS, pursuant to the Supreme Court (SC) decision, there is a need for the Sangguniang Panlungsod to ratify contracts entered into by the City Mayor for projects and services prior to the issuance of said decision;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the 6th Sangguniang Panlungsod to ratify the Construction Agreement entered into by the City Mayor Hon. Aldrin L. San Pedro, in behalf of the City Government of Muntinlupa with AP Melendrez Construction for the road concreting, drainage, sidewalk curve and gutter, streetlights, paving blocks and parking area located at Muntinlupa City Hall of Justice, National Road, Barangay Tunasan, Muntinlupa City in the amount of Ten Million Eight Hundred Eighty Six Thousand Six Hundred Sixteen Pesos and 04/100 (Php10,886,616.04) which amount shall be taken from the 2008 Supplemental Budget No. 1 - infrastructure project under the executive budget.

Approved, by the 6th Sangguniang Panlungsod of Muntinlupa this 21st day of June, 2011, on its 39th Regular Session.
